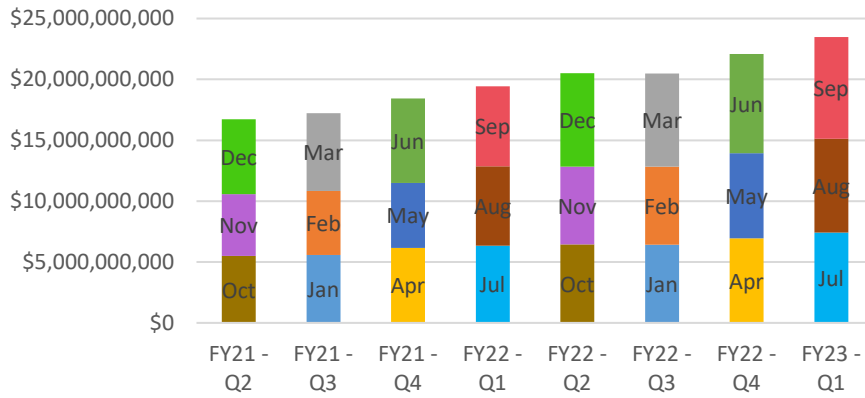

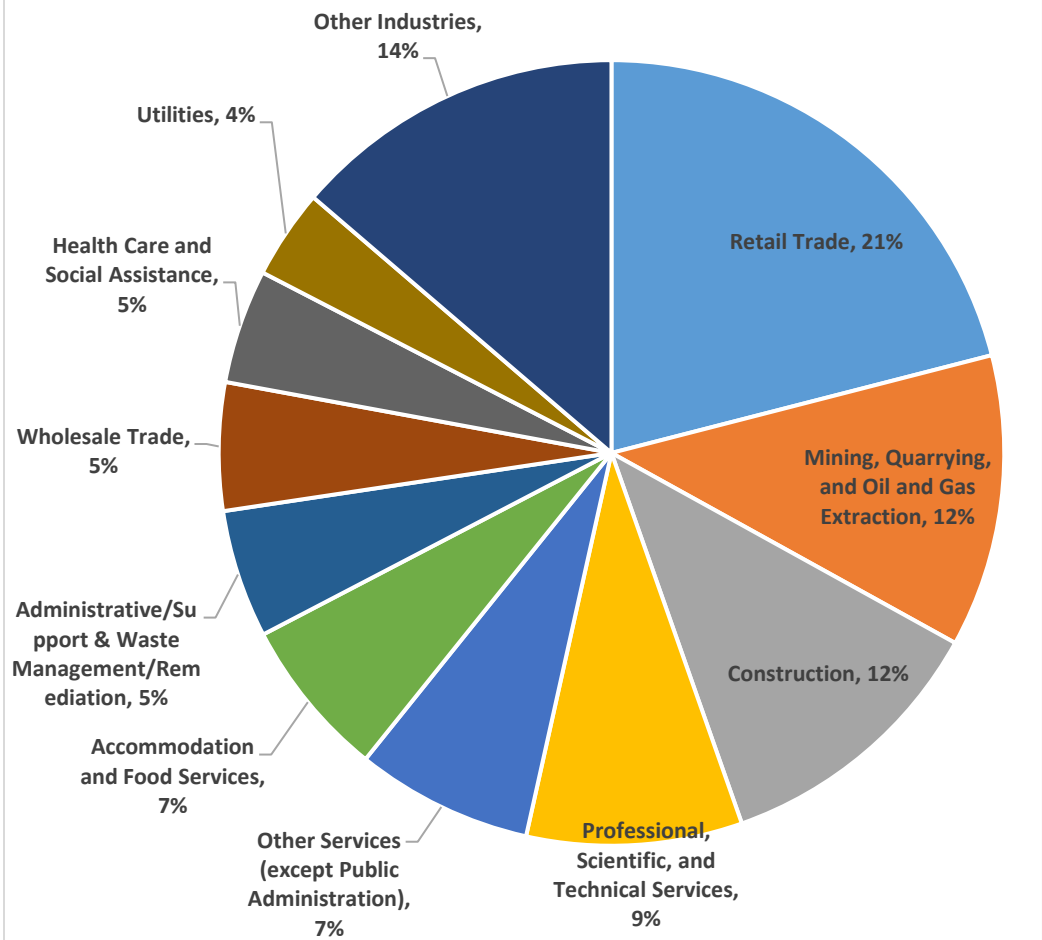
Chart 1. Matched Taxable Gross Receipts Per Quarter



New Mexico's total matched taxable gross receipts (MTGR), in Q1 FY23, increased to an all-time high. The amount reported during Q1 FY23 (\$23.5B) is 6.2% higher or \$1.38B more than the amount reported during Q4 FY22. Over the last eight quarters, MTGR has averaged \$19.79B or \$3.7B less than the amount reported during Q1 FY23. With the rather large increase in quarterly MTGR, New Mexico has an upward trend. As seen in Chart 2, the largest contributor to the quarterly MTGR came from the retail trade industry (21%). From Q4 FY22 to Q1 FY23, the retail trade industry decreased by 1%.

The agriculture, forestry, fishing, and hunting industry reported a negative amount in Q1 FY23, this is likely due to some form of taxpayer(s) amended return for prior periods. Table 1, on the next page, shows that the largest year-over-year (YOY) increase came from the oil and gas industry. When comparing the two time periods, the oil and gas industry grew by \$1.3B or 87%. The oil and gas industry accounted for nearly 33% of the YOY increase New Mexico experienced.

Matched Taxable Gross Receipts (MTGR) are the best tax data available to show underlying economic activity. The data collection process matches a tax payment with reported receipts for each taxpayer by industry.

The **Quarterly Census of Employment and Wages** or the **QCEW**, used in Charts 4-5, produces comprehensive data on the number of establishments, monthly employment and quarterly wages for workers covered by state unemployment insurance (UI) laws and federal workers covered by the Unemployment Compensation for Federal Employees (UCFE) program. These data are aggregated to many different levels, starting at the 6-digit NAICS industry level, to higher industry levels (NAICS industry groups, sectors, and supersectors), and to higher geographic levels (MSA, state and national). Data are based on information reported by New Mexico employers, covering 97% of nonfarm wage and salary workers. Data are published every quarter. Considered the gold standard for its reliability of industry data, the QCEW data are the most complete universe of monthly employment and quarterly wage information by detailed industry.

Chart 3. Monthly Matched Taxable Gross Receipts

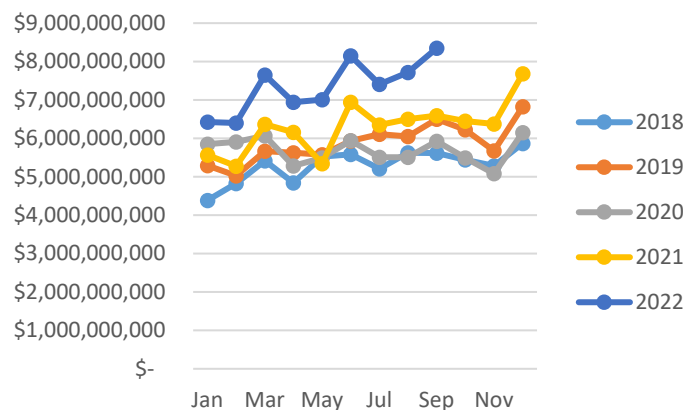
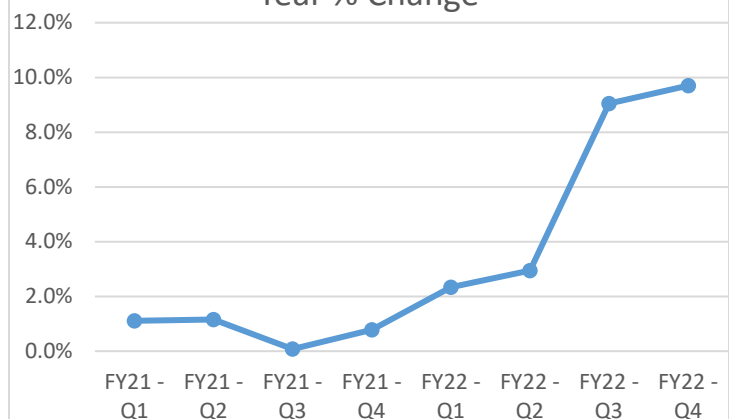


Chart 4. Establishment Year Over Year % Change

Chart 5. Total Employment & Weekly Wage

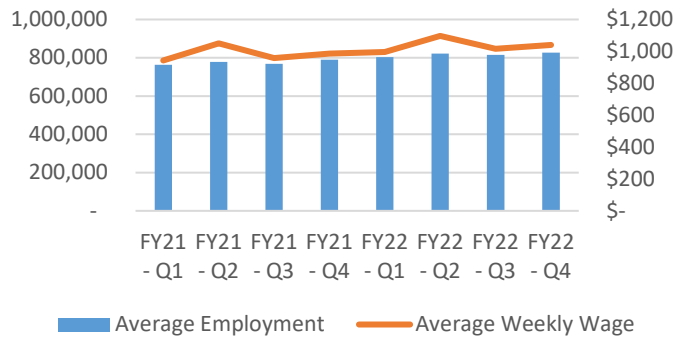
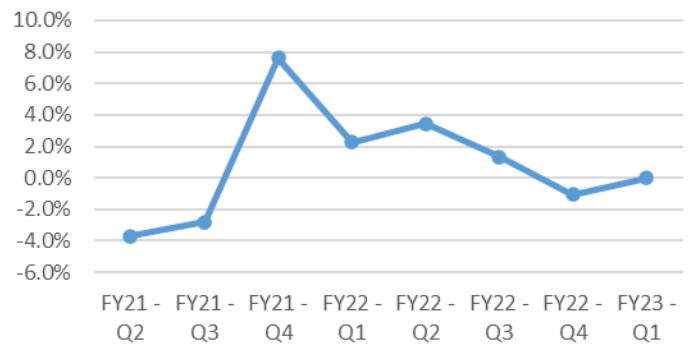


Chart 6. YOY % Change in GDP per Quarter

The percentage that GDP grew (or shrank) from one period to another is an important way for the state to gauge how the economy is performing. GDP in Chart 7-8 and Table 2 are real GDP in chained 2012 dollars.

Chart 7. Gross Domestic Product Per Quarter

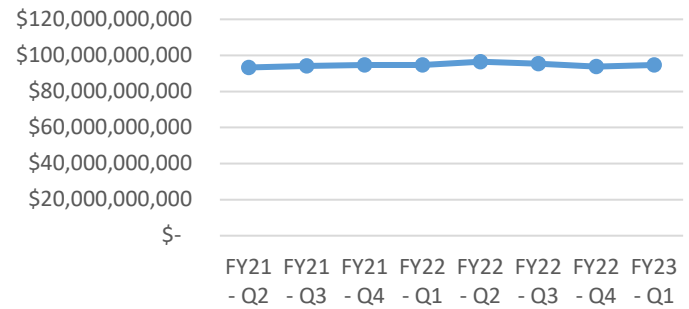

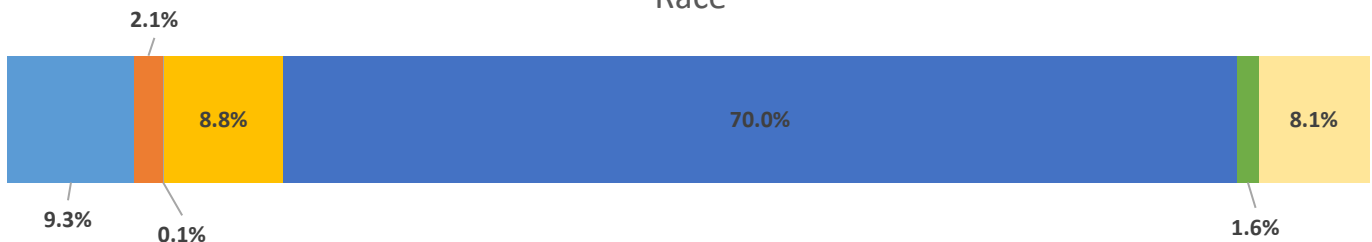

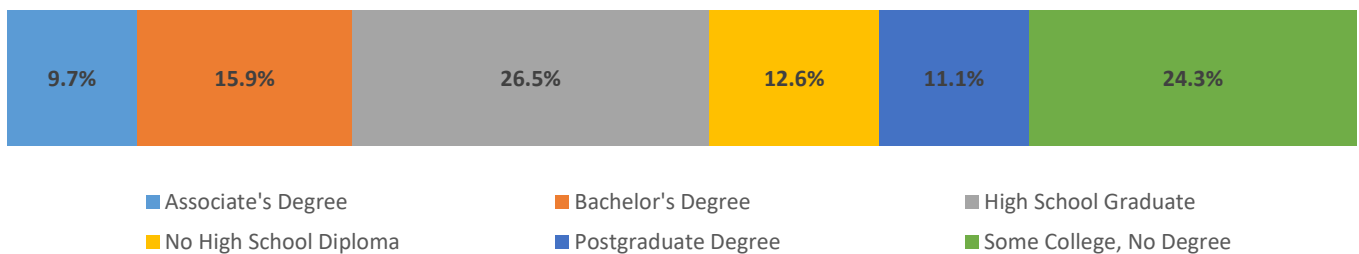
